We are writing to provide advance notice of price adjustments that will be implemented on April 1, 2025.

Recent actions to reinvigorate Section 232 tariffs on steel and aluminum have both direct and indirect cost impacts on several accessory categories within our product portfolio.

As a result, the following price adjustments will be implemented **April 1, 2025**. This increase is in addition to our previously announced Q1 2025 increase on membranes, polyiso, and accessories.

To maintain supply for all customers, order patterns will be monitored, and, if necessary, restricted to customary levels.

All orders will continue to be invoiced at the price that is valid at time of shipment, regardless of the date the order was placed. All active quotes will be honored through quote expiration. New quotes issued with quote validity past April 1 will reflect the price increase.

Updated accessory price books will be distributed detailing the price adjustments in advance of the increase effective date.
